MEMBERSHIP – All exhibitors and riders must be full members of the Shire Horse Society. Young Handlers must be either full members or Junior Members. Membership may be started/renewed on this entry form.

ELIGIBILITY - Please check class specifications carefully and that your horse(s) is/are eligible for the classes in which they are to be entered. Horses must be registered in the correct ownership and registration documents must be correct and up to date. If horses are on loan please state this on the entry form. Registration documents requiring updating may be enclosed with this entry form. Fees for transfer of ownership may be paid on the same cheque as entry fees. There is no fee for updates from Notified Colt to Non-Breeding, however a veterinary certificate of castration is required.

STABLES – these are to be booked on a separate stable booking form.

INSURANCE It is the responsibility of the exhibitor to ensure safety and security of all property and livestock on the Showground or elsewhere which is his own, or for which he is responsible.
